

## ELDORADO RESORTS ANNOUNCES REOPENING DATES FOR FIVE PROPERTIES IN FLORIDA, INDIANA, COLORADO AND OHIO

RENO, Nev.--(BUSINESS WIRE)-- Eldorado Resorts, Inc. (NASDAQ: ERI) ("Eldorado," "ERI," or "the Company") today announced the planned resumption of operations at five properties in Florida, Indiana, Colorado and Ohio, pending receipt of final regulatory approvals.

Eldorado plans to reopen Isle Casino Racing Pompano in Florida on Saturday, June 13, Tropicana Evansville in Indiana on Monday, June 15, Isle Casino Hotel Blackhawk and Lady Luck Casino Blackhawk in Colorado on Wednesday, June 17, and Eldorado Gaming Scioto Downs in Ohio on Friday, June 19.

Upon these reopenings, 21 of Eldorado's 23 casino entertainment facilities will have reopened following the suspension of operations in March.

"We are excited and grateful to be on track to reopen our casinos in Florida, Indiana, Colorado and Ohio very soon, following which 90 percent of our properties will have resumed operations. As we reopen our facilities across the country, the health and safety of our Team Members and Guests remains our priority. We have been working very hard over the last two months to prepare to welcome our Guests back and look forward to safely providing the outstanding service and hospitality experiences our casinos in Florida, Indiana, Colorado and Ohio are known for," said Anthony Carano, President and Chief Operating Officer of Eldorado Resorts.
