## Notice of IRC § 338 Election Pursuant to Treasury Regulations § 1.338-2(e)(4)

On April 22, 2021, Caesars Entertainment, Inc., a U.S. resident corporation and taxpayer, through its subsidiary, Caesars UK Holdings Limited, acquired all the outstanding shares of William Hill PLC not previously owned by Caesars Entertainment, Inc. or its subsidiaries.

Immediately following the posting of this notice, Caesars UK Holdings Limited will make elections under Section 338(g) of the Internal Revenue Code of 1986, as amended (the "IRC") with respect to the acquisition of William Hill PLC.

The requirement to deliver written notice of the IRC § 338 election applies only where the IRC § 338 election for the target corporation affects the income, gain, loss, deduction, or credit of the U.S. shareholder of the target corporation pursuant to the United States federal income tax rules applicable to controlled foreign corporations (IRC §§ 951, 951A, and 1248) or passive foreign investment companies (IRC § 1293).
