Explanation of Responses:

- Pursuant to a Retained Interest Agreement entered into in connection with the merger of Eldorado HoldCo LLC ("HoldCo"), the parent company of Eldorado Resorts LLC ("Resorts"), and MTR Gaming Group, Inc., (the "Merger"), Resorts issued shares of Common Stock to acquire the interest in Eldorado Limited Liability Company ("ELLC") not previously owned by Resorts. The value of the ELLC interest acquired by Resorts from Hotel Casino Management, Inc. ("HCMI") is approximately \$ 1,265,000.
- These shares are owned directly by HCMI. Raymond J. Poncia is a trustee and beneficiary of, and holds investment control over, the Raymond J. Poncia, Jr. Family Trust (the "Poncia Trust"), which holds a direct ownership interest in HCMI. Raymond J. Poncia and the Poncia Trust are indirect beneficial owners of the reported securities.
